

The following are basic responsibilities of students participating in Circle Theatre Company/Circle Studio Players. Students are to read and sign this form, which will serve as a contract that signifies their agreement to fulfill these responsibilities. In addition, parents or guardians should also sign this form to indicate knowledge of these responsibilities.

1. I acknowledge that classes are held every Friday, from 12:20 pm to 3:30 pm according to the Circle Christian School Arts Program class schedule.
2. I understand that *most* rehearsals will be conducted during class time. It is imperative that I attend all classes for the full three hours. Additional workshops and field trips may be required and will be announced in a timely manner. I further understand that some Saturdays and/or evenings *will* be involved. Additional rehearsals are tentatively scheduled as follows (please note, times and locations may be subject to change):

3. I understand that it is my responsibility to get the schedule for rehearsals and performances in advance and to make my parents/guardians aware of the times and days for which I am scheduled.
4. I have attached my current obligations (conflicts) for the extra rehearsals and tech weeks. I also agree not to add any obligations that will prevent me from attending the rehearsals during the times I have committed to be available.
5. I agree to make the director aware, at least one week ahead of time, of any short-term obligation for which I wish to be released from a rehearsal. I understand that, unless excused by the director, I am expected to be at the rehearsals for which I am scheduled.
6. I understand that there *may be* necessary changes to the rehearsal schedule and/or location and changes will be communicated either verbally during rehearsals and/or via e-mail communications. Any such changes will take into consideration any obligations that I have previously reported in item four above.
7. I agree to be on time for all rehearsals.
8. In case of emergency, I agree to let the instructor/director know of my late arrival or absence as soon as possible.

9. I agree to respect and cooperate with all staff and students involved in the production. I understand that I can be pulled from a production and/or lose the opportunity to participate in Circle Theatre Company in the future if I am disrespectful to anyone on the production team or engage in any inappropriate language or behavior.
10. As a member of Circle Theatre Company, I am a representative of Circle Christian School to the community and will not participate in any activities, including online activities (for example, on a MySpace or Facebook account), that would be deemed inappropriate. ***Participating in any inappropriate activities will result in being pulled from the show and possibly the program.***
11. I understand that by participating in Circle Theatre Company I am fully accepting an Ensemble role. I understand that an Ensemble role is a privilege and not any *less* of a role. I understand that if my attitude towards my role is improper it could result in my permanent removal from participating in the production.
12. I understand that by joining Circle Theatre Company I am making a commitment to Circle Christian School's Performing Arts program and to the other students in the program. I agree that I will make every effort to fulfill this commitment with excellence through dedication and service to our Lord Jesus Christ.
